COMPLAINT

- 1. Complainant brings this complaint before the Federal Election Commission ("FEC" or "Commission") seeking an immediate investigation and enforcement action against Yevgeny "Eugene" Vindman, Vindman for Congress, and Allison Murray in her official capacity as Treasurer ("Committee") for violations of the Federal Election Campaign Act ("FECA" or "Act").
- 2. This complaint is filed pursuant to 52 U.S.C. § 30109(a)(1) and is based on information providing reason to believe that:
- 3. Respondents have converted campaign funds for personal use in violation of 52 U.S.C. § 30114(b)(1) and 11 C.F.R. § 113.2(e).

STATEMENT OF THE LAW

- 4. 52 U.S.C. § 30114(b)(1) prohibits the conversion of contributions given to a campaign committee to personal use by any person.¹
- 5. Campaign funds are deemed to have been "converted to personal use if the contribution or amount is used to fulfill any commitment, obligation, or expense of a person that would exist irrespective of the candidate's election campaign or individual's duties as a holder of Federal office[.]"²
- 6. As a general matter, "[t]he expenses associated with marketing a book that a commercial publisher has published and for which it pays royalties to the author are expenses that exist irrespective of the candidate's election campaign or duties as a holder of Federal office. Therefore ... contributions accepted by a candidate may not be used to fulfill these expenses."
- 7. The Commission has long recognized that a political committee's mailing lists are assets that have value and "that are frequently sold, rented, or exchanged in a market." The use of a campaign committee's assets to promote a book "ordinarily constitute[s] a prohibited personal use of the contributions that paid for the asset." 5
- 8. The Commission has assessed "on a case-by-case basis" whether the use of campaign funds to purchase a candidate's book is an impermissible "personal use" based on the facts of each individual case.⁶
- 9. The Commission has approved the use of campaign funds to purchase a candidate's book in narrow circumstances when certain guardrails are applied to ensure that the candidate is not personally enriched. Specifically:

- Campaign funds may be used to make book purchases solely for distribution to contributors and supporters, and the quantity purchased may not exceed the number needed for such distribution.⁷
- The Commission has approved committee purchases of candidate-authored books only "if the publisher: (1) donates the candidate's royalties for his campaign's book purchases to a charitable organization that is not associated with the candidate and (2) excludes such sales from the calculation of royalties that accrue to the candidate."8
- The amount of promotional material posted on the campaign's website or social media pages
 to promote a candidate's book must be *de minimis*, which has been defined by the
 Commission to mean "a single sentence, or, at most, two sentences of promotional material
 about a candidate's book."9
- 10. 52 U.S.C. § 30114(b)(1) prohibits the conversion of campaign funds "by *any person* to personal use" (emphasis added). Accordingly, the restrictions the Commission has imposed on the use of campaign funds for disbursements for book purchases that generate royalties or other payments to a candidate apply equally to a candidate's use of campaign funds for book purchases that enrich the candidate's brother. "[N]either the candidate nor the candidate's authorized committee may convert contributions accepted by the candidate to the personal use of the candidate *or any other person*." ¹⁰

STATEMENT OF FACTS

- 11. Representative Vindman currently represents Virginia's 7th District in the U.S. House of Representatives.¹¹ His principal campaign committee is Vindman for Congress, and Allison Murray is the committee's treasurer.
- 12. Representative Vindman's brother, Alexander Vindman, is the author of a book titled, "The Folly of Realism: How the West Deceived Itself About Russia and Betrayed Ukraine" (hereinafter, "The Folly of Realism"), which was released on February 25, 2025.¹²
- 13. On February 27, 2025, Representative Vindman's campaign committee, Vindman for Congress, sent a fundraising email with the subject line: "Alex's New Book, The Folly of Realism: How the West Deceived Itself About Russia and Betrayed Ukraine, Unfortunately Couldn't Be More Timely and Accurate." The email states in part:

Alex isn't just known for his testimony that led to Trump's first impeachment – he has spent decades in national security, advising on U.S.-Russia strategy at the highest levels. He was the director for European Affairs on the National Security Council, served as the Political-Military Affairs Officer for Russia for the Chairman of the Joint Chiefs of Staff, where he wrote the Russia strategy, and as an attaché at the US Embassies in Moscow and Kyiv. His book reveals profound truths about the mistakes the U.S. repeats, how Western leaders enabled Putin's aggression, and provides a path for the U.S. to recapture moral leadership...Defending democracy starts with knowing the truth. If you want to stand with us, chip in \$50 dollars by March 7, 2025 to receive a copy. If you are one of the first 500 donors, you will get a signed edition.¹³

- 14. On March 7, 2025, Representative Vindman's campaign committee sent yet another fundraising email promoting Alexander's book, this one with the subject line, "LAST CHANCE: Get A Copy of Alex's New Book About the Truth of Russia and Ukraine." In addition to offering the book in exchange for a \$50 contribution, the bulk of this email includes copy written by Alexander touting his book and his foreign policy experience, and emphasizes that "[b]y donating \$50 today, not only will you be supporting my effort to set the record straight on Russia's invasion of Ukraine, but you will also be supporting my brother's movement to defend democracy from Trump's authoritarian takeover." 14
- 15. Vindman for Congress' 2025 April Quarterly Report disclosed that, on March 7, 2025, the same day that the committee sent the second fundraising email promoting Alexander Vindman's book "The Folly of Realism," it also made a \$7,809.55 disbursement for a "Fundraising Expense" to Books & Books, a retail bookstore in Coral Gables, Florida. Florida. On March 9, 2025, two days after Vindman for Congress reported making the \$7,809.55 disbursement to Books & Books, Alexander Vindman posted a photograph to his X account featuring him seated in a bookstore behind copies of "The Folly of Realism," with the caption, "Your Books are signed and on the way! Thank you for ordering from the iconic Books and Books in Miami Florida!" 16
- 16. Vindman for Congress' 2025 April Quarterly Report disclosed another disbursement, in the amount of \$30,972.97, made to Books & Books on March 20, 2025, also for a "Fundraising Expense." On April 12, 2025, Alexander Vindman posted additional photos on X that showed him seated in a bookstore alongside copies of "The Folly of Realism," and that included the caption, "Fort Books! Signed another 800 copies at the iconic @BooksandBooks in Coral Gables. Get you [sic] copy of The Folly of Realism." 18

CAUSE OF ACTION

AGAINST RESPONDENTS YEVGENY "EUGENE" VINDMAN, VINDMAN FOR CONGRESS, AND ALLISON MURRAY AS TREASURER

Converting Campaign Funds for Personal Use in Violation of 52 U.S.C. § 30114(b)(1) and 11 C.F.R. § 113.2(e)

- 17. The Commission has been clear regarding the facts and circumstances that need to be present for a book deal to be compliant with FECA. Most notable in this case is the overt promotion of a book authored by Representative Vindman's brother, Alexander. Marketing costs have been specifically highlighted by the Commission as an *expense of a person* "that would exist irrespective" of the campaign. Here, Vindman for Congress has significantly subsidized the marketing costs that should be borne by Alexander Vindman and his book's commercial publisher. The Commission's *de minimis* limitation on book promotion, delineated as a mere one to two sentences, is, in this instance, exhausted by a complete and promotive takeover by Alexander Vindman advertising his book. Therefore, Eugene Vindman and Vindman for Congress appear to have violated 52 U.S.C. \$\infty\$ 30114(b)(1) and 11 C.F.R. \$\infty\$ 113.2(e) by using campaign funds and assets to subsidize marketing expenses for Alexander Vindman's book in excess of the *de minimis* amount that the Commission has previously sanctioned.
- 18. Additionally, the Commission has recognized email lists as an asset of the campaign committee, thereby making the clear use of Vindman for Congress' email list to market Alexander Vindman's book through the fundraising emails sent on February 27 and March 7, 2025, respectively in the absence of fair market value compensation supportive of a finding that the Vindman for Congress

- campaign funds have been misappropriated for personal use by Representative Vindman and his brother, Alexander, in violation of 52 U.S.C. § 30114(b)(1) and 11 C.F.R. § 113.2(e).²¹
- 19. Furthermore, Vindman for Congress' two disbursements to Books & Books for "Fundraising Expense[s]," which together totaled more than \$38,782, appear to have been made for purchases of, and/or promotional events for, Alexander Vindman's "The Folly of Realism," as evidenced by the proximity of the disbursements' dates and when Alexander Vindman held book-signing events at Books & Books. Emails distributed by Vindman for Congress on February 27 and March 7, 2025 (see above), indicate the books were purchased by the campaign committee and then used as a fundraising tool. Accordingly, there is reason to believe that Vindman for Congress converted campaign funds to personal use by purchasing and promoting Alexander Vindman's book through the retailer Books & Books, in violation of 52 U.S.C. § 30114(b)(1) and 11 C.F.R. § 113.2(e). Publicly available information does not disclose other relevant details, such as the number of copies of "The Folly of Realism" purchased by Vindman for Congress, and what royalties Alexander Vindman received as a result of Vindman for Congress' book purchases.

PRAYER FOR RELIEF

20. Wherefore, the Commission should find reason to believe that Yevgeny "Eugene" Vindman, Vindman for Congress, and Allison Murray as Treasurer have violated prohibitions against converting campaign funds to personal use in violation of 52 U.S.C. § 30114(b)(1) and 11 C.F.R. § 113.2(e). The Commission should conduct an immediate investigation under 52 U.S.C. § 30109(a)(2) and determine and impose appropriate sanctions for any and all violations. Furthermore, the Commission should enjoin respondent from any future violations, and impose any necessary and appropriate remedies to ensure respondent future compliance with FECA.


